_____ I hereby authorize my lost/found dog to be immediately released to a representative of Doggidy Doo in the event I cannot be reached to immediately reclaim my adopted dog.

_____ I agree to provide care for my adopted dog, including, but not limited to: to spay/ neuter, if necessary, adequate high quality food, water, a clean shelter within a comfortable temperature range, and to provide necessary medical treatment and veterinary care, including yearly vaccinations. The dog will be treated as a family member with loving, care, affection, and respect.

_____ I agree to have my adopted dog under control when he/she is not within the confines of my property. This adopted dog shall not be chained or tied nor will he/she be an "outside" dog. I will not keep this dog outdoors for extended periods of time and I understand that this dog is an indoor companion. I will provide inside housing at all times.

_____ I agree to keep an identification tag attached to a properly fitted collar that will remain on the adopted dog at all times, whether inside or outside of the home, and to obtain all licenses required by local authorities. I will abide by all state and local laws regarding animal ownership. Dogs must be registered and licensed within your county of residence.

_____ I agree to never strike or otherwise physically or emotionally abuse this adopted dog. I further agree NOT to declaw, debark, crop ears/tail, or otherwise mutilate this dog.

_____ I understand that my adopted dog will need time to adjust to his/her new home and that the adjustment period could last for a few days or a few weeks. During this time, the dog may exhibit behavior that he/she will not otherwise exhibit after he/she adjusted to their new life. This may include housetraining accidents, escape attempts, excessive barking, and chewing among others. I understand that a consistent routine will give my adopted dog security and help him/her adjust more quickly. I will see out the help of a professional training if I need help with these issues, and upon request, Doggidy Doo will provide information on training options.

_____ I will transport this adopted dog inside an enclosed vehicle.

_____ Doggidy Doo may inquire about and/or request to examine the adopted dog from time to time. I agree that if the examiner is not satisfied with the conditions of the dog and/or this agreement has not been fulfilled, Doggidy Doo may immediately take possession of the dog and reclaim ownership of him/her without conditions.

_____ I hereby release Doggidy Doo from all liability for legal fees, veterinary care expenses or any other expense or liability incurred as a result of this adoption.

_____ I understand and agree that Doggidy Doo cannot guarantee the health, temperament, or training of the adopted dog and hereby release Doggidy Doo from all liability and agree to hold Doggidy Doo harmless once the dog is in my possession.

_____ **If for any reason I cannot keep this dog, I will notify Doggidy Doo and agree to surrender the dog back to Doggidy Doo. Under no circumstances, will I surrender the dog to ANY public shelter.**
